ADMINISTRATIVE MATTERS

<u>Change of Residence Requirement:</u> Chief Bellerive gave an explanation to the Board describing how a small expansion of the residency requirement would open the applicant pool. This topic had previously been brought before the Administrative Committee and approved.

Discussion ensued regarding how this change would improve the diminished applicant pool.

<u>MOTION:</u> It was moved by Director Oneto, seconded by Director Boitano, and unanimously carried to approve changing the residency requirement to "within 1 hour driving time from any Amador Fire Protection District Station".

<u>Conversion or Possible Sale of Engine 111:</u> Chief Woods gave an explanation to the Board that E-111 is currently at West Coast Frame in Sacramento, and it was estimated that the cost to convert E-111 to two wheel drive would start at \$20,000.00. The estimate to repair the current four wheel drive configuration would start at \$7,000.00.

The District would like to repair the engine and then market it for sale with Brindlee Mountain Fire. Discussion ensued regarding how the marketing would work with Brindlee Mountain Fire as well as the cost difference between the driveline options, and other current and potential future problems with the engine.

Direction to staff to repair the engine with the current driveline configuration, and market it with Brindlee Mountain Fire.
